General registration information:

1. The participant attends the course at his or her **own risk**.
2. Course Language is **English**.
3. The number of participants (enrolment) is limited.
4. Acceptance into this course is on a first come, first accepted basis, with fully completed and prepaid registration.
5. **Cancellation:**
 - For cancellations more than 10 weeks ahead of the first session there will be an administrative handling charge of **250€**; up to 30 days prior to the first session there will be **700 €** deducted from the tuition paid.
 - For cancellations less than 30 days prior the first session but greater than 14 days there will be an administrative handling charge of **1500€** deducted from the tuition paid.
 - Cancellations within the 14 days before the course begins will incur **no refund**. A replacement who also fulfills all the requirements may be presented.
 - Cancellations have to be sent in a written form to GerVAS (Use this address: K. Müller, Tierarztpraxis Quelle, Carl-Severing-Str. 163, 33649 Bielefeld, Germany or e-mail to: kurskoordinator@gervas.org). The date of the arrival counts as the date of the cancellation.
6. **No refund** will be offered for dropping the course in progress or missing sessions for personal reasons. It is possible to replace a participant by another licensed graduate veterinarian, if the tuition is paid.
7. GerVAS reserves the right to cancel the course because of organisation or other reasons until 14 days prior the date of the first session. In this case, the tuition will be refunded. GerVAS is not liable for variations of the exchange rate
8. GerVAS reserves the right to replace IVAS Speakers, if needed.
9. Approvals:
